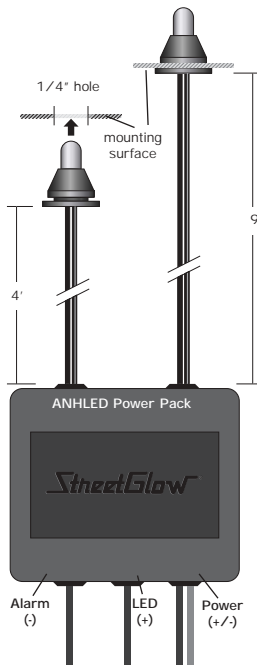
1 – Headlight LED System

### INSTRUCTIONS:

- 1) Mount LED Power Pack close to headlight housing using the double sided tape provided.  
\*Clean mounting surface free of dirt and oil deposits before mounting
- 2) When installing Headlight LED's, removal of the headlamp housing is recommended for easy installation. Locate the desired LED placement in the headlamp housing and drill a 1/4" hole.
- 3) Run LED wires to each headlamp housing and insert LED into 1/4" mounting hole until flush (see Mounting Diagram).
- 4) Power Connections
  - Yellow Wire = Constant 12v
  - Black Wire = Ground
  - Blue Wire = Negative (Alarm Status)
  - Orange Wire = 12v (Cruzin' Mode)
- 5) Enjoy!
