CONTENTS:

1- L.E.D. Alarm Indicator

MOUNTING INSTALLATION:

- Step 1 Select a desired location for your L.E.D. Alarm Indicator and drill a 5/16" hole.
- Step 2 Separate the Bezel from the L.E.D. (See Diagram 1)
- Step 3 Insert the L.E.D. from behind the hole and reassemble the bezel to the L.E.D. (See Diagram 2)

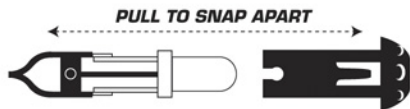

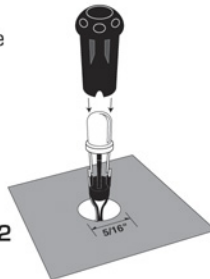
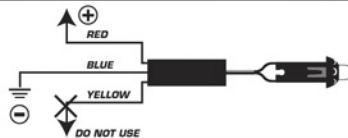


DIAGRAM 2

WIRING INSTALLATION WITHOUT ALARM SYSTEM:

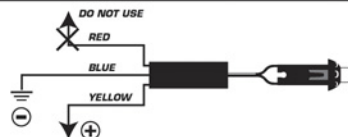
FOR A SLOWER FLASH SPEED:

- Red wire: 12V ignition (+) or Constant 12V
- Blue wire: Ground (-)
- Yellow wire: DO NOT USE



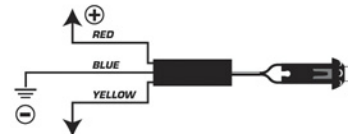
FOR A FASTER FLASH SPEED:

- Red wire: DO NOT USE
- Blue wire: Ground (-)
- Yellow wire: 12V ignition (+) or Constant 12V



WIRING INSTALLATION WITH ALARM SYSTEM:

- Red wire: Constant 12V
- Blue wire: Ignition (-) grounded when armed (ignition disable) L.E.D. will activate when alarm is armed.
- Yellow wire: 12V (+) accessory output when triggered (siren output) L.E.D. will flash at a faster speed when triggered.
