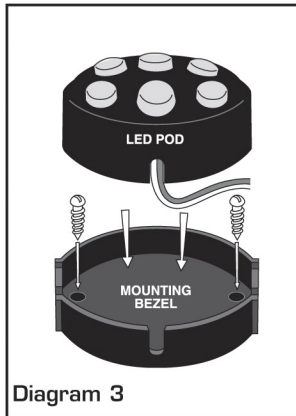
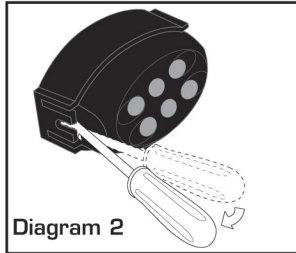
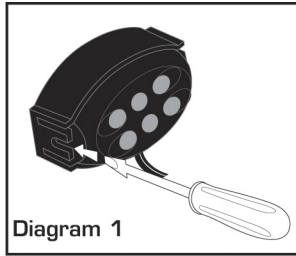
INSTRUCTIONS:

Step 1 Using small slotted screw driver slide screw driver between bezel and Pod.
(Diagram 1)

Step 2 Pry down on the Pod until it pops out of bezel.
(Diagram 2)

Step 3 Mount the L.E.D. Pod in the desired location using screws or double sided tape provided.
(Diagram 3)

Step 4 Make connection of power (+) and ground (-) harness.
STRIPED wire = 12v battery (+)
BLACK wire = negative ground (-)
